Hazards to Humans and Domestic Animals

CAUTION:

Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco.

First Aid:

If on skin or clothing:

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes

Environmental Hazards:

This product is toxic to fish. For terrestrial uses, do not apply directly to water or to areas where surface water is present or to intertidal area below the mean high water mark. Physical or Chemical Hazards:

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause container to burst. Do not apply this water-based product to conduits, motor housings, junction and switch boxes or other electrical equipment due to the possible shock hazards. Do not use on surfaces that may be damaged by water.

Directions for use:

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

HOW TO USE: SHAKE WELL BEFORE EACH USE

To kill flies, mosquitoes, and moths: Prior to application, close doors and windows in the area being treated. Hold container upright and spray upward in a sweeping motion to all parts of the room. Treat areas around windows and other light sources since flying insects are attracted to these areas. Leave room after spraying. Keep doors and windows closed for 15 minutes after treatment. Ventilate room when treatment is complete. Repeat treatment as necessary.

This product is non-staining to most surfaces. Do not use on surfaces that may be damaged by water. If unsure, first treat an inconspicuous area and check in a few hours for staining or damage.

Storage and Disposal:

Storage: Keep in locked storage area. Store in a cool dry place, away from heat, sparks and open flame. Do not store at temperatures over 130°F. Do not contaminate water, food or feed by storage and disposal.

Disposal:

Do Not Puncture or Incinerate!

If empty: Place in the trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
